"As our opposition to the settled plan of the [] Administration[, Congress, and the Courts] to enslave America will be strengthened by a union of all ranks of men [and women, and their children] in [this nation, and every State], we do most earnestly recommend that all former differences about [all less important issues, such as] religion or politics, and all private animosities and quarrels of every kind, from henceforth cease and be forever buried in oblivion; and we entreat, we conjure every [lawful American citizen] by his [or her] duty to God, his [or her] country, and his [or her] posterity, cordially to unite in defense of our common rights and liberties."

(Taken verbatim, except for words in [brackets], from the Maryland Resolves, December 12, 1774.)

A grossly perpetrated ignorance is propagated upon us as Americans through our schools, government, media, religious and civic institutions, and professional organizations. Such is illustrated by the fact that an organization was founded and structured by "the Articles of Association of 1774", which was specifically identified by President Abraham Lincoln in his first Inaugural Address. Lincoln stated as follows, also quoted verbatim:

"Descending from these general principles, we find the proposition that in *legal contemplation* the Union is perpetual *confirmed by the history of the Union itself*. The Union is much older than the Constitution. *It was formed, in fact, by the Articles of Association in 1774. (Emphasis added.)* It was matured and continued by the Declaration of Independence in 1776. It was further matured, and the faith of all the then thirteen States expressly plighted and engaged that it should be perpetual, by the Articles of Confederation in 1778. I submit to this organization and as a CCAC Member I will work to the best of my knowledge and ability at all times to assure that all that I learn and apply through this organization is never abused or misused by myself or others, and will keep all CCAC 2.1 and subsequent information strictly secure within CCAC.
